Emergency Preparedness Working Group (EPWG)

Asia Pacific Economic Cooperation (APEC)

1. Introduction

Most APEC economies are situated along the Pacific Ring of Fire, where strong earthquakes, tsunamis, and volcanic eruptions pose constant threats. The region is also the world's most frequented by tropical cyclone formations, including yearly occurrences of Category 5 cyclones, or super typhoons. Furthermore, the Asia-Pacific region is subjected to temperature changes in the Pacific Ocean, resulting in the El Niño and La Niña phenomena. Many of these conditions could be further exacerbated by climate change.

The APEC Emergency Preparedness Working Group (EPWG) was first established as the APEC Task Force for Emergency Preparedness (TFEP) by APEC Senior Officials in 2005. In 2009, APEC Leaders reaffirmed the importance of enhancing human security and reducing the threat of disruptions to business and trade in the Asia-Pacific Region. In 2010 the TFEP was elevated to an Emergency Preparedness Working Group (EPWG).

The Emergency Preparedness Working Group comprises heads and expert level staff of emergency management agencies, working with APEC member economies and private sector, who share experiences, lessons, tools, and the latest thinking related to disaster preparedness in order to strengthen regional cooperation and domestic and collective emergency preparedness efforts. The APEC EPWG brings together government officials from the region's various emergency management agencies to build its members' capacity to mitigate, prepare for, respond to, and recover from emergencies and disasters.

In 2015, APEC Leaders adopted the APEC Disaster Risk Reduction Framework (DRRF), primarily to address the pressing concerns resulting from the persistence of disasters in the Asia-Pacific region, which are considered to be the "new normal."

This "new normal" is characterized by at least two phenomena: the increasing frequency, magnitude and scope of disasters, and the resultant disruption of the increasingly integrated and interlinked production and supply chains of the region. It disrupts the free flow of trade and investment across economies; it presents tremendous challenges and serious threats to the inclusiveness and sustainability of growth and development in the region.

The importance of addressing environmental challenges has also been highlighted in the APEC Putrajaya Vision 2040 that was adopted by APEC Leaders in 2020. APEC Leaders stated that, "We will promote economic policies, cooperation and growth which support global efforts to comprehensively address all environmental challenges, including climate change, extreme weather and natural disasters¹, for a sustainable planet". The EPWG's work directly supports the Putrajaya Vision through cooperation on measures that increase economic and societal resilience to environmental challenges.

¹ The expression that will be used in this Strategic Plan is "disasters" instead of "natural disasters"

This Strategic Plan focuses on EPWG activities for the period 2021-2024 in line with the APEC Disaster Risk Reduction Framework.

2. Vision Statement

An Asia-Pacific region whose societies and economies are resilient to the increasing frequency, scope and intensity of disasters. EPWG will contribute to achieve APEC Vision 2040 particularly in promoting economic policies, cooperation and growth which support global efforts to comprehensively address all environmental challenges, including climate change, extreme weather and disasters.

3. Mission Statement

The EPWG's threefold mission is to:

- Develop capacity in the region so that APEC member economies can better mitigate, prepare for, respond to and recover from emergencies and disasters
- Improving intra-APEC coordination and cooperation around integrating best practices in emergency management and disaster preparedness
- Providing APEC economies with updated information on how to reduce the economic and social costs of disasters.

4. Critical Success Factors

Recognizing the multi-faceted characteristics of natural hazards and disaster management, the capacity of EPWG to successfully execute this plan will depend on a number of factors:

- Identifying the gaps to address that will help to enhance disaster risk reduction and emergency preparedness capacity in the APEC region
- Developing and strengthening public-private partnerships that support business and community resilience to disasters, including involvement of all levels of government, non-governmental organizations, and the private sector
- Enabling, a greater role for women in supporting disaster resilient businesses and communities
- Facilitating science and technology application to disaster risk reduction by sharing good practices and implementing EPWG projects
- Leveraging existing programs and resources to sustain long-term public-private collaboration and avoid duplication of effort
- Engaging and developing cross-cutting collaboration with APEC fora, as well as regional and international organizations whose work interacts with and complements the EPWG Strategic Plan priorities and objectives to ensure their awareness of and participation in EPWG projects
- Strengthening information sharing, best practices, and learning from experiences
- Encouraging direct participation of key stakeholders in the EPWG projects.

5. Agreed Priorities, Objectives and Key Performance Indicators (KPIs)

In order to achieve the EPWG's mission, the EPWG will work on the four overarching priority areas with the following outlined objectives to enable better focus on disaster risk reduction and emergency preparedness.

EPWG projects will be measured by the key performance indicators (KPIs) for their effectiveness in achieving EPWG objectives under each priority area. Member economies are encouraged and welcomed to utilize KPIs to report on the progress of projects on a voluntary basis.
